City of Auburn Council Meeting February 18, 2020

I. Mayor's Comments

Mayor Berola did not provide Mayor's Comments.

II. Visitors/Public Comments

A. Gordon D. Wayman – US Census Bureau (Chicago Region)

Gordon Wayman addressed the Council with information regarding the upcoming census. Wayman informed the Council that a letter will be sent to all residents with a code to go on-line (my2020census.gov) to register. If responses have not been received by April 8, a response card will be sent to that resident to register via snail mail. He also informed the Mayor that he could establish a Complete Count Committee to promote a complete census to respond. Wayman stressed that undercounted means no money to the City.

B. 201 W. Caldwell – Parsons

Alderman Sheppard asked for the residents of 201 W. Caldwell to address the Council regarding the overabundant amount of animal feces in their yard and what they were going to do about cleaning it up. Ashley Howard, resident of 201 W. Caldwell, indicated to the Council that as of 5:30 p.m. today, the yard was cleaned up. Howard did indicate that she was housing her own dogs and 4 dogs for a friend. Alderman Sheppard made an agreement that she would be rechecking the residence on Friday, February 21, 2020 and if it was not in compliance, further action would be taken. A motion was made by Sheppard that if 201 W. Caldwell does not become in compliant when checked on Friday, February 21, 2020, it will be deemed unsightly accumulations and will be declared a nuisance according to Ordinance 13-75/13-76 with fines at \$100 per day; second by Basiewicz. After the residents left the Council meeting, the Council then started to discuss the Ordinance regarding how many animals are considered a kennel. Attorney Moredock will check into the Ordinance and bring back to the Council additional information.

The Committee discussed with Narmont that what he was proposing was within the Ordinance and didn't need a variance to subdivide Briarwood Trace Subdivision (25" set back) into 4 parcels. Narmont then discussed construction projects on three to seven properties at 1100 W. Jefferson/Railroad Estates. The Zoning Committee instructed him to the Ordinance regarding mobile homes.
