I. Mayor's Comments

A. Tracy Sheppard (telephone)

B. Covid 19

Mayor Berola discussed with the Council the precautions that the City of Auburn will be taking. The City Office employees are not allowing patrons inside the building and they are encouraged to use the drive-up window for services. The City Garage employees will be on entering homes on the assumption that it is an emergency and will then shower at the firehouse prior to returning the garage and/or home. All clothes will be washed. The Police Office is under the same procedures of if encountering someone that they feel may be sick they will too shower at the firehouse and uniforms will be sent out to be cleaned. Berola instructed Becky Pisarek to cancel all of the reservations for the Community Center through April 2020. Alderman Royer brought up the issue of utility bills not being paid during this critical time. Royer felt that it was best to let citizens know that we are willing to work with them on their utility bill.
